Pursuant to Wis. Stat. 174 and Chapter 12, Lincoln County Code, every owner of a dog more than 5 months of age on January 1 of any year, or 5 months of age within the license year, shall annually, or on or before the dog becomes 5 months of age, pay the dog license tax and obtain a license. No such license shall be applied for without compliance with the rabies control section of the County Code, Wis Stat. 95.21 and any local ordinance pertaining to dog license and rabies shots.

**Penalty for Unlicensed Dog = \$100**
